

<b>Privacy Notice – Governors, Trustee &amp; Members Data</b>
<p><b>What is our lawful basis for processing this data</b></p> <p>Legal obligation</p>
<p><b>What data do we collect</b></p> <p>Governors &amp; Trustees: Name, date of birth, address, telephone number, occupation, DBS number            Next of Kin: Name, address, telephone number.</p>
<p><b>Why do we need it and what do we do with it</b></p> <p>Governors &amp; Trustees are required by law to provide personal data and for the Multi Academy Trust to perform the necessary checks to become a governor or Trustees. This includes:</p> <ul style="list-style-type: none"> <li>• Establish and maintain effective governance</li> <li>• Meet statutory obligations for publishing and sharing governors'/Trustees'/Members' details</li> <li>• Facilitate safe recruitment, as part of our safeguarding obligations towards pupils</li> </ul> <p>We retain governor information securely electronically on our IT systems.</p>
<p><b>How long do we keep it</b></p> <p>We hold this data up until a Governor, Trustee or Member ceases to volunteer for the Multi Academy Trust, plus one year.</p>
<p><b>Who we share this information with and why</b></p> <ul style="list-style-type: none"> <li>• Department for Education to meet our legal obligations to share information about governors/trustees/members (information stored on the national database of governors - "Get Information About Schools")</li> <li>• In the case of Trustees who are also Company Directors, with Companies House</li> </ul> <p>Other than this, we do not routinely share this information outside of our organisation, but may share this information with our legal or trusted advisers for the purpose of obtaining advice, with government agencies if required by law, or with law enforcement agencies for the prevention or detection of crime.</p>
<p><b>What are your rights</b></p> <p>You have a number of rights in relation to your personal information under data protection law. In relation to most rights, we will ask you for information to confirm your identity and, where applicable, to help us search for your personal information. We will respond to you within 30 days after we have received any request (including any identification documents requested).</p> <p>You have the right to:</p> <ol style="list-style-type: none"> <li>1. Ask for a copy of the information that we hold about you;</li> <li>2. Correct and update your information;</li> <li>3. Withdraw your consent (where we rely on it).</li> <li>4. Object to our use of your information (where we rely on our legitimate interests to use your personal information) provided we do not have any continuing lawful reason to continue to use and process the information.</li> <li>5. Erase your information (or restrict the use of it), provided we do not have any continuing lawful reason to continue to use and process that information;</li> <li>6. Transfer your information in a structured data file (in a commonly used and machine-readable format), where we rely on your consent to use and process your personal information.</li> </ol> <p>Please see our <a href="#">Data Protection Policy</a> for further information and for details of how to make a request.</p>
