<p>What is our lawful basis for processing this data</p> <p>Statutory obligation</p>
<p>What data do we collect</p> <p>Name and Information relating to your visit (your company or organisation name, arrival and departure time, car number plate)</p>
<p>Why do we need it and what do we do with it</p> <p>We collect this data to identify people on site in case of emergencies and maintain accurate records of visits to the school/college.</p> <p>This information is stored on our Administrative Sign in System at our Reception desks.</p>
<p>How long do we keep it</p> <p>We will keep this information while you are visiting our school/college and until the end of the academic year + 1 year</p>
<p>Who we share this information with and why</p> <p>We do not routinely share this information outside of our organisation, but may share this information with our legal or trusted advisers for the purpose of obtaining advice, with government agencies if required by law, or with law enforcement agencies for the prevention or detection of crime.</p>
<p>What are your rights</p> <p>You have a number of rights in relation to your personal information under data protection law. In relation to most rights, we will ask you for information to confirm your identity and, where applicable, to help us search for your personal information. We will respond to you within 30 days after we have received any request (including any identification documents requested).</p> <p>You have the right to:</p> <ol style="list-style-type: none"> 1. Ask for a copy of the information that we hold about you; 2. Correct and update your information; 3. Withdraw your consent (where we rely on it). 4. Object to our use of your information (where we rely on our legitimate interests to use your personal information) provided we do not have any continuing lawful reason to continue to use and process the information. 5. Erase your information (or restrict the use of it), provided we do not have any continuing lawful reason to continue to use and process that information; 6. Transfer your information in a structured data file (in a commonly used and machine-readable format), where we rely on your consent to use and process your personal information. <p>Please see our Data Protection Policy for further information and for details of how to make a request.</p>
